

# Building the fire service of the future

**The first of four new fire stations is scheduled to open this summer as Cheshire Fire Authority continues its programme to fundamentally change how its emergency response service will be provided in the future.**

With crews attending 50% less incidents than a decade ago, the programme aims to ensure future staffing is more in line with risk and activity levels and that the new stations improve overall average response times.

The on-call station at Alsager is due to open in July 2015, with around 16 local people being trained to work as part-time firefighters. Planning permission has also been obtained for full-time fire stations at Penketh near Warrington, Powey Lane near the M56 and at the Lymm motorway junction.

Work on these starts in 2015-16 with the Lymm development integrating a fire station with a state of the art training and safety facility. The iconic circular building will feature scenarios aimed at raising awareness of a wide range of risks to young people, older people and carers.

Total cost of the building programme is £15.5 million and it is hoped this will be fully funded from grants and reserves. Changes in how some stations will be crewed are making a major contribution to

the near £8 million savings the Authority needs to make over the next four years due to cuts in its funding.

In 2015-16 savings of £1.9 million are required, with £950,000 coming from the emergency response changes and the rest mostly from a major value for money review across back office areas.

In addition, the Authority is increasing its Council Tax level by 1.99% which means that the amount for a Band D home will be £70.46 – an increase of £1.37 or 2.6p per week.

As well as the new stations, the Authority's capital programme for 2015-16 includes:

- £840,000 for three new fire engines
- £700,000 on a new hydraulic platform to help firefighters work at height
- £170,000 to fit all fire engines with new computers so crews can get the latest risk information.

## Facts and figures



Cheshire Fire & Rescue Service operates:

- 24 Fire Stations
- 4 Community Safety Centres
- 3 Community Fire Protection Offices
- A Headquarters and training facility.

The Authority provides a 24 hour service to just over 1 million people and employs some:

- 663 operational staff
- 229 community safety and other support staff.

## Fire budget 2015–16



The Fire Authority has agreed that a budget of £42.2 million is required to provide a fire and rescue service to the communities of Cheshire East, Cheshire West and Chester, Halton and Warrington areas for 2015–16.

With £17.44 million provided through Government grants and Business rates, it means that £24.51 million will need to be raised from local Council Tax, which is equivalent to £70.46 for each Band D dwelling. This is a rise of 1.99%, or 2.6p a week for a Band D home.

The budget equates to a cost per resident of just 81p per week.
