JOB PURPOSE

To play a key and flexible part in supporting the planning and delivery of all operational and command training through undertaking a proactive approach to setting up fire-ground scenarios, both practical and virtual. To clear away all used scene deposits and ensure teaching and training areas are left clean, tidy and safe.

To assist in maintaining buildings and resources through undertaking a proactive role in setting up and removal of physical resources including training props and training equipment. To clean buildings after training use and to undertake standard testing of items of equipment and support the replacement plan for consumable items.

To act as a safety person and a role player as and when required.

To operate and use Fire Service equipment commensurate with the role.

PRINCIPAL RESPONSIBILITIES

- 1 Be responsible to the Training Station and Watch Managers in supporting the planned physical and virtual training programme on a day-to-day basis.
- 2 Set up training sites and facilities in a timely manner ready for day-to-day delivery of the day's training programme. To include:
 - Fire Appliance siting and hose layout when required
 - BA sets and ancillary Breathing Apparatus and Positive Pressure Ventilation equipment preparation
 - Fire House preparation to include fire building of cribs
 - Fire loading of containers
 - Positioning of vehicles for RTC scenarios
 - Preparation of Petro Chemical Training Rig
 - Preparation of rural training area

- Work in accordance with Safe Systems of Work and arrange additional assistance as and when required.
 - Complete safety checks of facilities and maintain records.
- 3 Prepare classrooms, and other training areas as required.
 - 4 Clean and tidy training sites and areas after training has ceased when safe and timely to do so. Maintain agreed standards of housekeeping in all training and teaching areas, to include:
 - Removal of waste water from training buildings.
 - Removal of fire debris from training buildings.
 - Removal of extrication training vehicles and vehicle debris
 - Checking all safety features such as lights, doors, vents.
 - Checking consumable stocks for Fire Houses
 - Checking consumable stocks for Fire Behaviour training compartments
 - Checking LPG levels for petro chemical training rig and other areas
 - Replace props in correct storage area, monitor their wear and tear
 - 5 Maintain Training Fire Appliances and Tele Handler. Ensure they are clean and ready for operational use.
 - 6 Maintain own Personal Protective Equipment in accordance with Service Policies.
 - 7 Undertake defined routine checks of Training Equipment to ensure its operational readiness for training events and maintain records.
 - 8 Report on stock levels of all revenue training resources and arrange for the ordering of equipment, cleaning supplies and consumables where required
 - 9 To act as a safety person in designated training scenarios.
 - 10 To act as a role-player in designated training scenarios.
 - 11 Practice and promote the Health and Safety policies of Cheshire Fire and Rescue Service to ensure the development and progression of health and safety within the sphere of responsibility of this job description and the health and safety of all employees and customers.
 - 12 Promote equality and diversity in the Service and the Community in accordance with the Authority's Equality and Opportunity Policy.
 - 13 Undertake appropriate initial and refresher training as required by the role.

Personal Performance

To take responsibility for personal performance (including personal fitness) and the development of personal skills to ensure the required skills, knowledge and competence to fulfil the role.
